INSTRUCTIONS

NEW APPLICANT

Note: Utah Code Ann. § 76-10-503 does not require a person to obtain a permit to carry a concealed firearm if they are "21 years old or older" and "may otherwise lawfully possess a firearm." Check bci.utah.gov for questions and answers regarding carrying a concealed firearm in Utah without a Concealed Firearm Permit.

Anyone, at least 21 years of age, may apply for the Utah Concealed Firearm Permit. Permit is valid for 5 years.

Anyone, between 18 years of age and 20 years of age, may apply for the Utah Provisional Concealed Firearm Permit. Provisional Permits are valid until permit holder's 21st birthday.

Original applications must be accompanied by all required documentation (see below). Every application must be signed by the applicant prior to submission. Only original applications will be accepted.

If applying by mail, please send application and all required documentation in a 9 x 12 envelope.

PAYMENT OPTIONS

The Bureau accepts cash, check, money order, VISA, MASTERCARD, AMERICAN EXPRESS and DISCOVER. Credit card payment must include the 3 or 4 digit control number on the back of the card.

Name must be imprinted on checks (no "counter checks" please). Please make check or money order payable to: **BCI.** There will be a \$20 service charge for returned checks. **PLEASE DO NOT SEND CASH IN THE MAIL.**

□ PHOTOCOPY OF YOUR DRIVER LICENSE OR STATE ISSUED IDENTIFICATION CARD

BCI does offer fingerprint services. The fee is \$15.00 Must make an appointment online at BCI.UTAH.GOV for fingerprint services

☐ PHOTOGRAPH:

One recent <u>color</u> photograph of passport quality (2x2, no hats or sunglasses). NAME MUST BE ON BACK OF PHOTO

☐ Application must include permanent physical residence and mailing address (if applicable).

☐ NON-RESIDENT PROOF OF PERMIT

If you reside in a state that recognizes the validity of the Utah CFP or has reciprocity with Utah, you must obtain a CFP or CCW from your home state and submit a copy with the expiration date visible. For a list of reciprocal states visit: **BCI.UTAH.GOV** You are considered a resident of whichever state issued your ID. If your state does not recognize the Utah permit this does not apply. If you are applying for a Provisional Concealed Firearm Permit and your state honors the Utah Provisional Permit you must include a copy of your state's concealed firearm permit.

☐ FINGERPRINT CARDS:

Blue and white (FD-258) Applicant fingerprint cards can be obtained from BCI or your local police department. Fingerprint cards must be filled out completely, including signatures of both the applicant and official. **USE BLACK INK ONLY**. Writing and prints must be legible. Fingerprint cards that are not legible will be returned to the applicant and will cause a delay in processing the application. Private businesses and many local law enforcement agencies provide this service, check your local listings.

☐ APPLICANTS BORN OUTSIDE OF U.S.:

If you were born outside of the U.S. you must include your Alien Registration Number or INS Registration Number on your application and fingerprint card, or include a copy of your U.S. issued born abroad birth certificate. A copy of a valid U.S passport will also be accepted for proof of citizenship if born outside the US.

☐ WEAPON FAMILIARITY CERTIFICATION:

Applicants must complete a firearms familiarity course, certified by the Bureau, before applying for a permit. Please have your instructor complete the certification information on the application. Holders of a valid Concealed Firearm Permit from a state other than Utah are <u>not</u> exempt from taking the weapon familiarity course from an approved Utah instructor. **BCI must receive your application within one year from the date the course was completed.** A copy of your Utah Provisional Permit may be used to satisfy Weapon Familiarity Certification if Provisional Permit is less than 1 year expired.

☐ APPLICATION PROCESSING

Upon receipt of your completed application packet, we will process your payment. Applications will be reviewed in the order they were received. Upon completion of the background investigation, if the application meets criteria established by law, the permit will be mailed to you. Please do not call to check the status of your permit; the review process may take up to 60 days.

WARNING

Falsification of any information in the application may result in denial or revocation of a permit and possible criminal prosecution.

Be sure to provide all supporting documents: one complete fingerprint card, one photo (with name on back), photocopy of resident state's permit with expiration date visible (if resident state honors the Utah CFP) and photocopy of drivers' license.

Enclose the appropriate fee, \$53.25 for Utah residents or \$63.25 for non-residents in the form of credit card, money order or check made payable to "BCI". Name must be imprinted on check. Cannot accept foreign credit cards.
